## Students vote in favour of a U-Pass at Sheridan College

**December 3, 2018 (Oakville, ON):** From November 26-30, full-time students at Sheridan were asked to vote in a U-Pass Referendum, jointly hosted by the Sheridan Student Union (SSU) and Sheridan College. Students were able to vote in favour of, or against, the implementation of a Universal Transit Pass (U-Pass) that would provide unlimited ridership on public transit routes operated by the three municipal transit authorities in Brampton, Mississauga, and Oakville for all eligible full-time students at Sheridan College.

For results to be binding, a minimum of 15% of eligible voters were required to participate in the referendum. The SSU and Sheridan College are happy to report a voter participation rate of 25%, with 4,805 of the 19,260 eligible full-time Sheridan students casting their ballots last week.

In the online vote, eligible students were asked if they were in favour of establishing a non-refundable ancillary fee of \$197.15 per term to enable the proposed U-Pass to be introduced at Sheridan College. The votes were as follows:

2742 - YES 2063 - NO

The majority of voters were in support of the U-Pass implementation and as a result, SSU will work collaboratively with Sheridan College to begin Steering Group meetings immediately with our transit partners to ensure a seamless transition to the U-Pass.

Sheridan Student Union is pleased to have had such strong support from Oakville, Mississauga (MiWay) and Brampton Transit (including Züm) as partners in the formulation of the successful U-Pass proposal, and looks forward to working closely with each of the partners in order to secure official municipal approval of the proposed U-Pass proposal, as we work towards a September 2019 implementation.
